



THE FINANCIALS OF FUNDRAISING

The Standard Chartered Mumbai Marathon is today the most cost effective fundraising option available for charities in India. United Way of Mumbai absorbs all the payment gateway charges incurred online to ensure 100% of the amount donated on our online pages is disbursed to NGO's.

The entire charity structure is based on keeping the costs of fundraising as low as possible at the individual giving level as reflected in the above table with 96% to 99.4% of funds raised in the individual categories going to the beneficiary charity.

An extraordinary couple, who wish to remain anonymous, has come forward this edition to motivate NGOs to raise funds for their organization.
